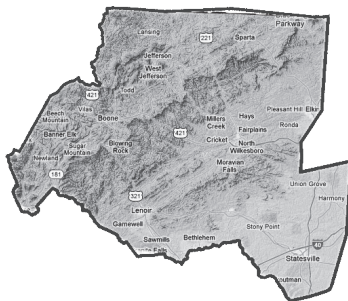
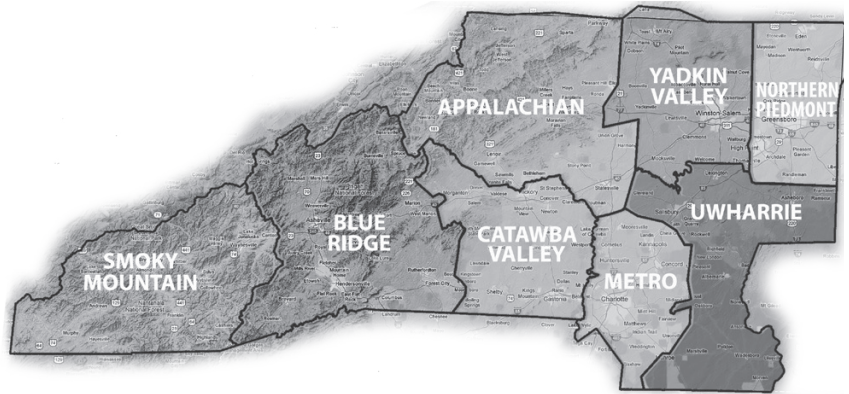


## II. DISTRICT ORGANIZATION

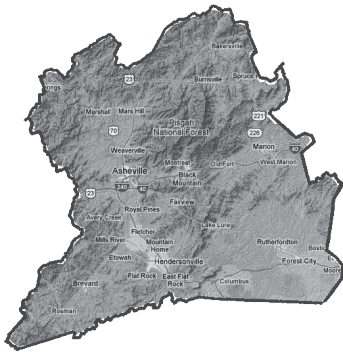

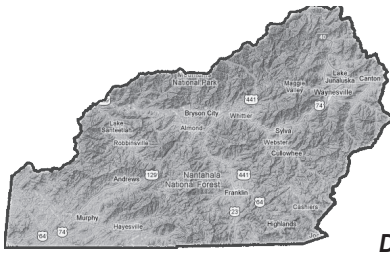

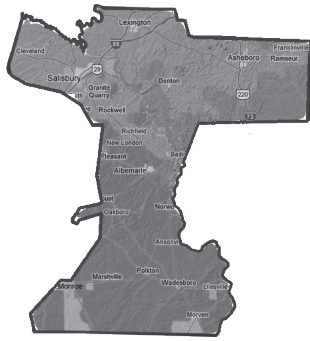
